Partnering for the Health of Mom and Baby

MHS Health is committed to taking steps to address the <u>maternal health crisis</u> affecting the entire United States. While the overall rate of <u>maternal mortality in Wisconsin</u> is lower than the U.S. average, the disparity in mortality rates between Black and white mothers is <u>greater in Wisconsin</u>.

MHS Health supports prenatal, birth, postpartum, and infant care aimed at reducing maternal mortality, improving birth outcomes, and bettering the overall health of mom and baby through interventions such as:

- Promoting early notification of pregnancy
- Pursuing care management for women with comorbidities
- Managing behavioral health issues
- ✓ Addressing care gaps
- Identifying social determinants of health
- Connecting women with community-based resources
- Encouraging attendance at prenatal and post-partum medical appointments

Maternal health programs, such as MHS Health's <u>Start Smart</u> <u>for Your Baby</u>[®], proactively address many of the factors that can lead to maternal mortality and adverse birth outcomes. The use of doulas has also been shown to improve health outcomes for mom and baby, as well as the experiences of pregnancy, birth, and postpartum. (NCBI)

In April, MHS Health partnered with Pacify Health to launch the first virtual doula program for Wisconsin Medicaid members. Pacify Health uses a 360-degree engagement strategy to provide on-demand, virtual access to a nationwide network of maternal and pediatric experts to improve population health, engage members, and reduce costs.

Every health plan member who is either currently pregnant or up to two months postpartum have the option to enroll in Pacify at no cost. Once enrolled, she has instant, roundthe-clock, and unlimited access to resources through an easy-to-use app where she can talk via live video chat with a doula or lactation consultant during her pregnancy and up to a year after delivery. Topics range from creating a birth plan to breastfeeding. She will also receive push notifications based on pregnancy status, such as scheduling prenatal or well child visits.
